

LOT 185, THE SETTLEMENT AT WILLOW GROVE, PHASE 2, 5TH FILING, PART 2:

COMMENCE AT THE PROPERTY CORNER COMMON TO LOTS 185, 186 AND THE WESTERN RIGHT-OF-WAY LINE OF LANE'S END, SAID POINT BEING THE POINT OF BEGINNING

THENCE PROCEED NORTH 61°06'22" WEST A DISTANCE OF 212.98 FEET; THENCE PROCEED NORTH 51°36'09" EAST A DISTANCE OF 23.00 FEET; THENCE PROCEED NORTH 41'33'40" EAST A DISTANCE OF 50.00 FEET; THENCE PROCEED SOUTH 61'06'22" EAST A DISTANCE OF 15.00 FEET; THENCE PROCEED NORTH 28'53'38" EAST A DISTANCE OF 5.00 FEET: THENCE PROCEED SOUTH 61'06'22" EAST A DISTANCE OF 185.00 FEET TO THE WESTERN RIGHT-OF-WAY LINE OF LANE'S END; THENCE PROCEED SOUTH 28°53'38" WEST ALONG THE WESTERN RIGHT-OF-WAY LINE OF LANE'S END A DISTANCE OF 11.21 FEET; THENCE PROCEED ALONG AN ARC OF A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 12°16'34", A RADIUS OF 300.00 FEET, AN ARC LENGTH OF 64.28 FEET AND A CHORD WHICH BEARS SOUTH

BASIS FOR ELEVATIONS:

ALL ELEVATIONS SHOWN HEREON ARE REFERENCED OFF OF AND RELATIVE TO NATIONAL GEODETIC SURVEY BENCHMARK "EBR035B" WITH A PUBLISHED ELEVATION OF 43.3 FEET N.A.V.D. '88 GPS OBS (2006.81). THIS IS A LOUISIANA HEIGHT MODERNIZATION SURVEY STATION.

TEMPORARY SITE BENCHMARK:

TOP OF NORTH BOLT ON CATCH BASIN LOCATED ON THE EAST SIDE OF LANE'S END, NEAR THE SOUTHWEST CORNER OF LOT 188. ELEVATION = 24.18 FEET N.A.V.D. '88.
